

SIARD Archive Browser – The Components^{*}

Abstract. The Software-Independent Archival of Relational Databases (SIARD) project developed a tool known as the “SIARD Suite” for preserving relational databases. The tool converts a relational database to a XML format. This paper presents the components of the SIARD Archive Browser which is a simple to use and platform-independent tool for browsing a SIARD Archive. This may be helpful for users interested in using the software. Moreover, it may be useful for people who want to re-use the code and develop software for browsing a SIARD archive with more functionality.

Keywords: SIARD, database dissemination.

1 Browser Components

The SIARD Archive Browser¹ is a free, platform-independent and easy to use tool developed in Java. It offers functionality including viewing table data, sorting a table by a column, searching a specific value in a table and joining tables (left join) [1].

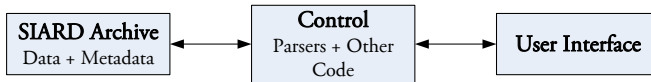


Fig. 1. Basic Architecture

The architecture of the SIARD Archive Browser is presented in Figure 1. The SIARD archive is generated by the SIARD Suite. It contains the archived data and metadata. The browser has a very simple user interface for users to retrieve data. The control component includes different parsers for retrieving data from the archive based on some criteria. Users interact with the user interface, the control component mediates the input, converts it to commands for retrieving data from the SIARD archive and processes data before displaying it on screen.

The control component has sub-components which interact with each other to process the data. The sub-components include the following.

- Path: This component manages the file paths in the archive. Different file paths are set including the metadata file path and the table files paths when a user opens an archive for browsing.

- Parsing Metadata File: The `metadata.xml` file is parsed using the XML DOM parser. There are two reasons for using the DOM parser for parsing this file. Firstly, the size of this file is small and it does not require a lot of memory. Secondly, the browsing process requires the extraction of pieces of metadata which can be done easily using the DOM parser.
- Parsing a Table for Displaying: Users may choose to access a table and search the data in it. A SAX XML parser is used for loading all the data in a table which requires lesser memory for the operation than to DOM parser.
- Parsing a table to identify the single matching row: When a base table is displayed on screen, a user may click on any of the foreign keys in the table. Clicking a value in a foreign key column displays the single matching row in the referenced table. A SAX XML parser is used for this functionality which parses the referenced table till the matching row is found.
- Parsing a table to identify all referenced rows: When a table referenced by the base table is displayed on screen, a user may click on the key column used as a reference in the base table. The SAX XML parser for this functionality parses all the base table. The matching rows are identified and displayed on screen.
- Joining tables: The software supports joining (left join) the base table with the tables it references. The result includes all the rows from the base table joining them with the tables it references, one at a time.

These components may be re-used in other software with more functionality for disseminating a SIARD archive. For example they may be re-used to develop a software for browsing SIARD archives stored in a DSpace² repository.

2 Future Work

This is a work in progress and in the future support for browsing large objects in an archive will be included. Furthermore, the functionality of joining tables in which users may include some criteria (SQL ‘where’ clause) will be included.
