Work Area:

Project overview: The Torre do Tombo national archive (TT) has the most relevant cultural heritage collection, including archival description metadata represented according to ISAAD / ISAAR standards. With the inclusion of large volumes of born-digital information, the interoperability requirements in cultural heritage repositories have grown and representations are sought to satisfy them. In this work, a CIDOC Conceptual Reference Model (CRM) model is developed for the metadata in the TT archives.

Objectives: - Identification of CIDOC-CRM classes and properties to be used in the TT model; - Selection of sets of items representative of national archival fonds and associated descriptions; - Proposal of a CIDOC-CRM model to be used in TT archives; - Validation of the model.
