Project overview: The project aims to develop an innovative e-learning model for advanced programming (software architectures and their development), called e-SimProgramming. This model will include team activities, resorting to Web platforms (Moodle LMS, Web 2.0, others) and virtual worlds & games (e.g. OpenSimulator). It is necessary to define, design, and develop integrated Web solutions to manage and analyse data and activities among students, and between then and teachers, across this diversity of platforms.

Objectives: Design, develop, and evaluate Web solution for monitoring (dashboards) and for online collaboration for the collective activities of the e-SimProgramming model. Design, develop, and evaluate, solutions for collection and analysis of research data, to enable the analysis of the model's performance and its tuning throughout the project. Draft and present documents reporting research results.
