

# CALL FOR GRANT APPLICATIONS (AE2020-0095)

INESC TEC is now accepting grant applications to award 1 Research Grant (BI) within the scope of the project TRF4p0, cofunded by the ERDF - European Regional Development Fund, through the Operational Programme for Competitiveness and Internationalisation - COMPETE 2020 Programme and by National Funds through the FCT - Portuguese Foundation for Science and Technology, I.P. on the scope of the MIT Portugal Program on the scope of POCI-01-0247-FEDER-045926 for 36 months.

## **1. GRANT DESCRIPTION**

Type of grant: Research Grant (BI)

## General scientific area: INFORMATION SCIENCE

#### Scientific subarea:

**Grant duration:** 12 months, starting on 2020-09-01, with the possibility of being renewed for a maximum term of four years, in the cases of students enrolled in a PhD.

Scientific advisor: António Lucas Soares

Workplace: INESC TEC, Porto, Portugal

Maintenance stipend: € 1064,00, according to the table of monthly maintenance stipend for FCT grants, paid via bank transfer. Grant holders may be awarded potential supplements, according to a quarterly evaluation process (Articles 19, 21 and 22 of the Regulations for Grants of INESC TEC and Annex II), up to a maximum limit of 50% of the monthly maintenance stipend.

Costs attributable to INESC TEC may include registration, enrolment or tuition fee stipend, either directly or through reimbursement, during the grant duration.

The grant holder will benefit from health insurance, supported by INESC TEC.

#### 2. OBJECTIVES:

- Participation in research activities of the project Transformer4.0 (2020-2023), a flagship project of the MIT-Portugal program. The grant holder will be involved in a team of researchers from INESCTEC, Efacec, INEGI and MIT. The specific activities to be developed are:

- Design the data and information model as well as the supporting IT infrastructure to manage Digital-Twins, both individually and networked;

- Design and prototype the digital-twin platform;

# 3. BRIEF PRESENTATION OF THE WORK PROGRAMME AND TRAINING:

- Broaden the knowledge in the state-of-the-art in the scientific area of the grant;
- Identify and select the adequate methods for the research work to develop;
- Develop skills in conducting research in the design of digital platforms for digital-twin;
- Develop critical spirit in the evaluation of the research process and the results obtained;



## 4. REQUIRED PROFILE:

### Admission requirements:

Master's degree in Information Science or similar

The awarding of the fellowship is dependent on the applicants' enrolment in study cycle or non-award courses of Higher Education Institutions.

## Preference factors:

Enrollment in a doctoral program in Information Science or similar; Experience in participating in research projects;

## Minimum requirements:

- Fluency in English (spoken and written);
- Undergraduate and master's degree average over 14;
- 1 scientific publication in a conference or journal with peer-review process;
- 1 project report written in english.

# 5. EVALUATION OF APPLICATIONS AND SELECTION PROCESS:

**Selection criteria and corresponding valuation:** the first phase comprises the Academic Evaluation (AC), based on the criteria referred to in Article 12 of the Regulations for Grants of INESC TEC, while the second phase comprehends the Individual Interview (EI). All factors are evaluated on a scale of 0 to 100, taking into account the applicants' merit, suitability and conformity with the preference factors.

The weight of the AC factors are as follows: Academic Qualifications (FA, 50%), Scientific Publications (PC, 20%), Experience (EX, 20%) and Motivation Letter (CM, 10%).

Candidates who score less than 50 points in the AC average will be considered excluded on absolute merit. The top five candidates approved on absolute merit will be qualified for the individual interview. The Final Grade (CF) is obtained by the weighted average of AC (80%) and EI (20%).

**Release of results and prior hearing:** the results of the selection process, as well as the terms and procedures for prior hearing, will be released to the applicants by email, under the terms referred to in Article 13 of the Regulations for Studentships and Fellowships of INESC TEC.

# 6. FORMALISATION OF APPLICATIONS:

# **Application Documents:**

- 1. Motivation letter;
- 2. Curriculum Vitae (must include the list of previous fellowships, their type, beginning and end dates, funding entities and host institutions);
- 3. Certificate or diploma degree dully recognised in Portugal;
  - Documents proving the awarding of academic degrees and diplomas, or the according recognition in cases of academic degrees or diplomas granted by a foreign higher education institution can be dismissed in the application process, and replaced by the applicant's declaration of honour, with the verification of said condition taking place during the grant's hiring stage.
- 4. Proof of enrollment in a degree awarding study cycle or in a non degree awarding Higher Education program.
  The proof of enrollment may be presented just during the grant hiring stage.
- 5. Signed declaration stating the infringement of the grant holder's duties (article 14, no. 4)
- Documental evidence to support the country of residence, residence permit or other legally equivalent document, in cases where the applicant is a foreigner or non-resident in Portugal - valid until the beginning of the grant.
- 7. Other supporting documents relevant to the final assessment.

Failure to deliver the required documents within the 90-day period after the date of the notice of the conditional awarding of the grant implies its cancellation.
