

# CALL FOR GRANT APPLICATIONS (AE2020-0228)

INESC TEC is now accepting grant applications to award 1 Research Grant (BI) with the reference PANDORA funded by CE, project (reference

### **1. GRANT DESCRIPTION**

Type of grant: Research Grant (BI)

General scientific area: COMPUTER SCIENCE

Scientific subarea: Programming, Informatics

**Grant duration:** 12 months, starting on 2021-01-15 with the possibility of being renewed for a maximum term of two years, in the cases of students enrolled in a master's degree.

Scientific advisor: António Pinto

Workplace: INESC TEC, Porto, Portugal

Maintenance stipend: € 805,98, according to the table of monthly maintenance stipend for FCT grants, paid via bank transfer. Grant holders may be awarded potential supplements, according to a quarterly evaluation process (Articles 19, 21 and 22 of the Regulations for Grants of INESC TEC and Annex II), up to a maximum limit of 50% of the monthly maintenance stipend.

Costs attributable to INESC TEC may include registration, enrolment or tuition fee stipend, either directly or through reimbursement, during the grant duration.

The grant holder will benefit from health insurance, supported by INESC TEC.

### 2. OBJECTIVES:

- Study the state-of-the-art on searchable encription
- Measure performance of the selected approaches
- Implement a web-based REST API for searchable and sharable encryption
- 1 Scientific paper

#### 3. BRIEF PRESENTATION OF THE WORK PROGRAMME AND TRAINING:

When exchanging cyber intelligence information a key issue to address is to enable the use of searchable encryption when performing information searching and sharing. Relevant information is expected to be stored on a node in the premises of each party in an encrypted form. On one side, this will add one level of protection and will offer encryption of stored data. On the other, it may hamper information search, filter and sharing. A suited searchable encryption technique will be selected in order to enable data sharing, remote filtering and searching without requiring access to the clear text information. An asynchronous searching mechanism will enable that a given party could query the other parties' encrypted storages (or nodes) for results that match specific values of selected parameters (dates, IoC, IP addresses,...), never supplying clear text data about such values. The encrypted results will be returned by each node to the querying node that, in turn, will decrypt and use the returned information. A web-based REST API will facilitate the communication between nodes.

## 4. REQUIRED PROFILE:

#### Admission requirements:

Degree in Computer Science

The awarding of the fellowship is dependent on the applicants' enrolment in study cycle or non-award courses of Higher Education Institutions.

## Preference factors:

Degree in Computer Science. Design and implementation of distributed systems. International experience in the area.

### Minimum requirements:

Chair of distributed systems, minimum grade 17.

# 5. EVALUATION OF APPLICATIONS AND SELECTION PROCESS:

**Selection criteria and corresponding valuation:** the first phase comprises the Academic Evaluation (AC), based on the criteria referred to in Article 12 of the Regulations for Grants of INESC TEC, while the second phase comprehends the Individual Interview (EI). All factors are evaluated on a scale of 0 to 100, taking into account the applicants' merit, suitability and conformity with the preference factors.

The weight of the AC factors are as follows: Academic Qualifications (FA, 40%), Scientific Publications (PC, 5%), Experience (EX, 35%) and Motivation Letter (CM, 20%).

Candidates who score less than 50 points in the AC average will be considered excluded on absolute merit. The top five candidates approved on absolute merit will be qualified for the individual interview. The Final Grade (CF) is obtained by the weighted average of AC (80%) and EI (20%).

**Release of results and prior hearing:** the results of the selection process, as well as the terms and procedures for prior hearing, will be released to the applicants by email, under the terms referred to in Article 13 of the Regulations for Studentships and Fellowships of INESC TEC.

# 6. FORMALISATION OF APPLICATIONS:

#### **Application Documents:**

- 1. Motivation letter;
- 2. Curriculum Vitae (must include the list of previous fellowships, their type, beginning and end dates, funding entities and host institutions);
- 3. Certificate or diploma degree dully recognised in Portugal;
  - Documents proving the awarding of academic degrees and diplomas, or the according recognition in cases of academic degrees or diplomas granted by a foreign higher education institution can be dismissed in the application process, and replaced by the applicant's declaration of honour, with the verification of said condition taking place during the grant's hiring stage. The submission of the certificate is mandatory when signing the contract.
  - Academic degrees or diplomas awarded by a foreign higher education institution require an authentication by a Portuguese higher education institution, and the corresponding registration on the DGES platform, in conformity with Decree-Law no. 66/2018, of August 16, and Ordinance no. 33/2019, of January 25. - Proof of enrollment in a degree awarding study cycle or in a non degree awarding Higher Education program.
  The proof of enrollment may be presented just during the grant hiring stage.
- 5. Signed declaration stating the infringement of the grant holder's duties (article 14, no. 4)
- Documental evidence to support the country of residence, residence permit or other legally equivalent document, in cases where the applicant is a foreigner or non-resident in Portugal - valid until the beginning of the grant.
- 7. Other supporting documents relevant to the final assessment.
