

CALL FOR GRANT APPLICATIONS (AE2021-0098)

INESC TEC is now accepting grant applications to award 1 Research Grant (BI) within the scope of the INESC TEC LA funded by National Funds through FCT - Portuguese Foundation for Science and Technology, I.P., project (reference UIDB/50014/2020

1. GRANT DESCRIPTION

Type of grant: Research Grant (BI)

General scientific area: COMPUTER SCIENCE

Scientific subarea:

Grant duration: 6 months, starting on 2021-07-01 with the possibility of being renewed for a maximum term of one year, in cases where the grant has been awarded to students who are enrolled in non-award courses, or up to two years, in the cases of students enrolled in a master's degree.

Scientific advisor: João Marco

Workplace: INESC TEC, Braga, Portugal

Maintenance stipend: € 835,98, according to the table of monthly maintenance stipend for FCT grants (http://www.fct.pt/apoios/bolsas/valores), paid via bank transfer. Grant holders may be awarded potential supplements, according to a quarterly evaluation process (Articles 19, 21 and 22 of the Regulations for Grants of INESC TEC and Annex II), up to a maximum limit of 50% of the monthly maintenance stipend.

Costs attributable to INESC TEC may include registration, enrolment or tuition fee stipend, either directly or through reimbursement, during the grant duration.

The grant holder will benefit from health insurance, supported by INESC TEC.

2. OBJECTIVES:

The work to be carried out during this research grant is part of the research work in management Mobile digital identification (mID).

This grant aims to study multi-platform development frameworks that allow access and extension to the functionalities of the Operating System of mobile devices.

3. BRIEF PRESENTATION OF THE WORK PROGRAMME AND TRAINING:

- State-of-the-art study on multi-platform solutions of cross-development for Android and iOS mobile platforms;

- Design and implementation of the necessary specifications to the requirements in mID not immediately

covered by the cross development solutions that may be adopted;

- Proof of concept mID implementation

The tasks described in this working plan demand the application and development of concepts and techniques in the area of Software Engineering which are usually introduced in curricular units included in the curricula of the Mestrados Integrados em Engenharia Informática ou de Mestrado em Engenharia Informática studies



4. REQUIRED PROFILE:

Admission requirements:

- Hold a BSc in Informatics Engineering, or similar, - Be enrolled in a Master's in Informatics Engineering The awarding of the fellowship is dependent on the applicants' enrolment in study cycle or non-award courses of Higher Education Institutions.

Preference factors:

Knowledge and experience in digital mobile identification. Knowledge of cryptography and information security Knowledge of systems administration Knowledge and experience in web application development Knowledge and experience in mobile application development

Minimum requirements:

Knowledge in digital mobile identification. Knowledge of systems administration Experience in developing solutions do mobile identity systems Proficiency in Portuguese and English

5. EVALUATION OF APPLICATIONS AND SELECTION PROCESS:

Selection criteria and corresponding valuation: the first phase comprises the Academic Evaluation (AC), based on the criteria referred to in Article 12 of the Regulations for Grants of INESC TEC, while the second phase comprehends the Individual Interview (EI). All factors are evaluated on a scale of 0 to 100, taking into account the applicants' merit, suitability and conformity with the preference factors.

The weight of the AC factors are as follows: Academic Qualifications (FA, 50%), Scientific Publications (PC, 10%), Experience (EX, 20%) and Motivation Letter (CM, 20%).

Candidates who score less than 50 points in the AC average will be considered excluded on absolute merit. The top five candidates approved on absolute merit will be qualified for the individual interview. The Final Grade (CF) is obtained by the weighted average of AC (70%) and EI (30%).

Release of results and prior hearing: the results of the selection process, as well as the terms and procedures for prior hearing, will be released to the applicants by email, under the terms referred to in Article 13 of the Regulations for Studentships and Fellowships of INESC TEC.

6. FORMALISATION OF APPLICATIONS:

Application Documents:

- 1. Motivation letter;
- 2. Curriculum Vitae (must include the list of previous fellowships, their type, beginning and end dates, funding entities and host institutions);
- 3. Certificate or diploma degree dully recognised in Portugal;
 - Documents proving the awarding of academic degrees and diplomas, or the according recognition in cases of academic degrees or diplomas granted by a foreign higher education institution can be dismissed in the application process, and replaced by the applicant's declaration of honour, with the verification of said condition taking place during the grant's hiring stage. The submission of the certificate is mandatory when signing the contract.
 - Academic degrees or diplomas awarded by a foreign higher education institution require an authentication by a Portuguese higher education institution, and the corresponding registration on the DGES platform, in conformity with Decree-Law no. 66/2018, of August 16, and Ordinance no. 33/2019, of January 25. - Proof of enrollment in a degree awarding study cycle or in a non degree awarding Higher Education program.
 The proof of enrollment may be presented just during the grant hiring stage.
- 5. Signed declaration stating the infringement of the grant holder's duties (article 14, no. 4)

- Documental evidence to support the country of residence, residence permit or other legally equivalent document, in cases where the applicant is a foreigner or non-resident in Portugal - valid until the beginning of the grant.

Failure to deliver the required documents within the 90-day period after the date of the notice of the conditional awarding of the grant implies its cancellation.

7. BINDING LEGISLATION AND REGULATION
